Migrant Labour Recognised as Key to Strengthening **EU** Employment According to a recent publication from the DG Home Affairs, migrant labour plays a vital role in boosting employment and addressing workforce shortages across the EU. The Commission highlights that migrants contribute significantly to essential sectors such as healthcare, agriculture, and construction, helping sustain Europe's economic growth and demographic balance. Migrants, specially those in vulnerable situations, need safe, stable, and inclusive pathways for migration to work and live with dignity. Ensuring fair labour conditions, equal treatment, and protection from exploitation is vital to building a resilient and competitive European economy. **EU Ministers Call for Stronger Action Against Violence Against Women** EU equality ministers call for a stronger focus on prevention, early detection, and intervention against gender-based violence. They emphasised the importance of awareness, education, and

assembly and association warns that these fundamental freedoms, along with collective action and solidarity, are facing existential threats worldwide. The report calls for increased resources and the removal of barriers such as "foreign agent" laws, the institutionalisation of meaningful participation by civil society, as well as to strengthen their resilience, sustainability, and autonomy. ACCESS TO JUSTICE Major Gaps in Compensation for Victims of Human **Trafficking** New data revealed that fewer than 1% of the thousands of victims of human trafficking identified in recent years have received government compensation. Experts also confirmed that compensation through criminal proceedings is also rare, as authorities often fail to identify or freeze traffickers' assets, leaving victims without access to justice or guidance on available remedies. The findings underscore the urgent need for training officials to recognise trafficking indicators and to strengthen victims' access to compensation and recovery support. **Knowledge Hub for Ukrainian Judiciary**

The Asser Institute has launched a Knowledge Hub on International Criminal Law to strengthen Ukrainian judges' capacity to address war crimes and other international crimes. With over seven

million people displaced abroad and four million internally, displacement and conflict have heightened vulnerabilities, which increases the risk of human trafficking and exploitation. Strengthening judicial capacity is crucial to safeguarding justice and human rights.

UN Convention Against Cybercrime Signed in Hanoi

On 25-26 October 2025, representatives of UN member states, international organisations, and civil society gathered for the signing of the UN Convention against Cybercrime, hosted by the Government of Vietnam. The treaty aims to strengthen international cooperation against crimes committed in and through the digital sphere, including online recruitment and exploitation, marking a major milestone in global digital governance. Its success, however, will depend on effective national implementation and strong safeguards for human rights and data protection. Civil society has also warned that, without these safeguards, the treaty could be misused to restrict civic space

and fundamental freedoms. The Global Initiative Against Transnational Organized Crime presented new research on cyber scams and cyber-enabled organised crime during the event.

Secondly, Exploitation of Surrogacy as a Form of Human Trafficking - How Did It End Up in the Amended EU Anti-Trafficking Directive?, examines how surrogacy was introduced into EU law, **Human Trafficking Awareness Week**

To mark the EU Anti-Trafficking Day (18 October), La Strada International launched a week-long awareness campaign focused on the newly recognised forms of human trafficking included in the amended EU Anti-Trafficking Directive: trafficking for the exploitation of surrogacy, of forced

marriage, and of illegal adoption. Throughout the week, LSI ran a dedicated social media campaign and organised two expert webinars exploring the complexities of the exploitation of surrogacy and forced marriage as forms of exploitation and their link with human trafficking. The week concluded with a statement urging EU institutions and Member States to strengthen efforts to address all forms of human trafficking LSI has published its 2024 Data Report, offering an overview of assisted presumed victims by our members and related trends in human trafficking across Europe. Drawing on data from members, the report shows that in 2024, LSI members collectively assisted over 5,400 persons, reflecting an increase from previous years. Women continue to represent the majority of assisted persons (67%), while men accounted for 32%, with sexual and labour exploitation remaining the most frequently reported forms. Notably, two-thirds (66%) of the assisted persons were citizens of non-

Open Gate, from North Macedonia, has published a new Analysis on Forced Marriage. The report reflects the experiences of many, particularly girls from marginalised communities across Europe, whose lives are constrained by poverty, social stigma, and institutional neglect. It highlights how coercion is often disguised as "tradition," and how economic hardship is used to justify exploitation. The analysis also offers concrete

- **Violent Crime** The Court of Justice of the European Union (CJEU), in the context of the Irish compensation scheme, clarified that although the 2004 Compensation Directive does not explicitly mention nonmaterial harm suffered by victims of intentional crimes, its broad wording does not limit the scope of compensation. The Court held that "no distinction can be drawn according to the types of harm which the victims of the crimes committed may have suffered or the consequences to which those victims may be exposed". It further underlined that measures to facilitate compensation form part of the realisation of the objective of ensuring the protection of the persons concerned from harm.
- **European Parliament Rejects Omnibus I Mandate to Weaken Sustainability Rules** Last October, the European Parliament's Legal Affairs Committee (JURI) approved a compromise under the Omnibus Simplification Package to scale back corporate sustainability reporting and due diligence requirements within the EU's Green Deal framework. The agreement raises reporting thresholds and limits liability and supply chain obligations, reflecting political pressure to ease regulatory burdens amid Europe's shift to the right. However, on 22 November, the Parliament rejected the JURI Committee's Omnibus I mandate, reopening negotiations and giving pro-EU forces a chance to safeguard human rights, access to justice, and corporate

beyond minimum legal obligations, presenting increasingly structured and comparable sustainability disclosures. The study highlights that the very transparency requirements some policymakers seek to dismantle are already driving meaningful change in corporate behaviour.

At the Berlin Process Foreign Ministers' Meeting on the Western Balkans in Belfast, UK Foreign Secretary Yvette Cooper announced £10 million in funding for programs to counter human trafficking along the Balkan route. The summit, part of the UK's presidency of the initiative, emphasised regional stability, the combating of organised crime, and addressing irregular migration flows through closer European cooperation. We hope that this funding programme will also support the work of our member organisations in the Balkans.



UN Experts Warn EU Against Rights Risks in Migrant Smuggling Rules Three UN Special Rapporteurs - on trafficking in persons, human rights defenders, and the human rights of migrants - have sent a joint letter to EU lawmakers expressing concern over the proposed reforms to the EU Facilitation Directive. They caution that the draft rules "raise serious

Forces Nearly 40 MEPs have urged the European Commission to halt financial and operational support to Libyan security forces, citing rising violence against humanitarian and migrant vessels. The call follows new evidence from an Italian journalist who filmed Libyan militias allegedly throwing migrants into the sea during a Mediterranean rescue operation. The NGO Mediterranea Saving Humans, which conducted the rescue, has submitted the footage to prosecutors and the International Criminal Court, urging human trafficking charges against those involved. They warned that continued cooperation with actors linked to human rights abuses undermines the EU's credibility and contributes to regional instability.

As part of the Clean Clothes Campaign's Fashioning a Just Transition programme, Arisa has published The Fast Fashion Waste Mountain, the first in a new series exploring the social and environmental impacts of textile recycling. The paper offers practical advice and exposes the vast amount of clothing waste generated across Europe. Future papers will address working conditions in textile recycling and links to responsible business conduct. Contributions to the Fashioning a Just Transition Manifesto are open until 16 November 2025.

UN Report Warns of Growing Threats to Civic Space

UN Experts Call to Protect Civic Space in Anti-Corruption Fora UN human rights experts have urged State Parties to the UNCAC to enhance transparency and safeguard civic space in the Convention's review mechanism. In a joint statement, they stressed the need to ensure meaningful civil society participation in anti-corruption efforts at both national level and UN fora. The experts called on states "to recognise civil society not as an obstacle, but as an indispensable partner in combating corruption and promoting human rights". See OHCHR's press release.

Greece Adopts Controversial Labour Law Extending Work Hours The Greek Parliament has approved a contentious labour law allowing 13-hour workdays, despite widespread opposition, nationwide strikes, and union warnings that the reform increases the risk of worker exploitation.

EU Launches New Biometric Border Management System On 12 October 2025, the new Entry/Exit digital border management system (EES) was launched and will be rolled out across 29 European countries over the course of the next six months. The system will digitally record entries and exits of non-EU nationals travelling for short stays, collecting passport data, fingerprints, and facial images, which will be stored for up to 3 years. Many organisations have raised concerns about data protection and privacy risks linked to the storage and use of biometric information.

doubts about their compatibility with international human rights obligations" and could lead to the criminalisation of migrants, as well as those offering assistance for family or humanitarian The Solution: Regular Migration Pathways At the Global Forum on Migration and Development, OHCHR launched a paper on Leveraging Regular Migration Pathways for Human Rights. The report stresses that when safe and accessible migration routes are absent, inaccessible or insecure, people on the move are pushed into irregular pathways, increasing their vulnerability, as well as the risk of exploitation and human trafficking. There is a need for inclusive, stable, and secure migration pathways. It calls on governments to scale up, diversify, and improve regular migration options as a foundation for rights-based migration governance, social cohesion, and dignity for all. Concerns Over UK-France Returns Scheme Amid Trafficking Reports An Iranian asylum seeker deported to France under the UK's new "one in, one out" migration deal has re-entered the UK by a small boat, claiming exploitation by traffickers and fearing for his life in France. Rights groups report increasing cases of violence and forced labour among migrants in northern France, raising concerns over the safety and viability of the returns scheme as Channel

crossings reach record levels. **Eurocarers Calls for Inclusion of Migrant Care Workers in EU Care Strategies** Eurocares released a position paper Integrating Migrant Care into European and National Long-Term Care Strategies, highlighting major gaps in care provision across Europe. The organisation stresses that migrant care workers - often informal and invisible - are essential to the sector, yet face poor conditions that harm both carers and care recipients. Eurocarers urges the EU to address these shortcomings and align policies with the goals of the European Care Strategy. MEPs Urge End to EU Support for Libyan Security

- Two Years of the German Supply Chain Act The European Center for Constitutional and Human Rights (ECCHR) has released Two Years of the German Supply Chain Act, an interim assessment showing that the law is already generating positive effects, yet it also reveals gaps in enforcement. Following the government's announcement to abolish reporting requirements and restrict sanctions to cases of "severe human rights violations," both companies and enforcement authorities appear to be paying less attention to complaints and affected individuals. Slavery: Confronting Historical Injustice Human trafficking and exploitation are not new challenges to human dignity; they are deeply rooted in the historical memory of many Western countries. A new Asser Institute publication explores different approaches to colonial legacies.
