

Overview of La Strada International's work in 2025

Research

LSI worked on 9 research papers, of which 4 were published in 2025.

Publications & statements (and submissions)

In total, LSI published 5 own statements, 13 joint statements and 11 publications.

- **14 January** – [joint statement](#) Omnibus proposal - 168 NGOs call upon the European Commission to actively safeguard EU corporate accountability laws, reaffirm the official timeline for their transposition and implementation, and ensure full transparency regarding the Omnibus process.

- **9 February** – La Strada International co-signed a [Position Paper on Gender Stereotypes](#), submitted by the Dutch CEDAW network as input for the CEDAW's General Discussion on Gender Stereotypes.
- **12 February** - La Strada International joined more than 60 organisations in signing a joint [statement](#) calling on EU leaders to step up and protect Global Development Aid in response to alarming policy shifts by the Trump administration.
- **19 February** - LSI has co-signed a [joint statement](#) calling for sustainable and independent support for civil society.
- **24 February** - launch of [LSI Report: Trafficking Risks Among Displaced Ukrainians - La Strada International](#)
- **4 March** – [joint statement](#) on Three years since the activation of the Temporary Protection Directive: from emergency to longer-term solutions – calling upon EU Member States not to

roll back support to people displaced from Ukraine, and to fully implement the provisions enshrined in the TPD.

- **6 March** - La Strada International has co-signed a [statement](#) sharing our solidarity with the people of Serbia. Together with over 130 civil society organisations (CSOs), we have expressed our concern with the recent developments in Serbia, particularly the escalating repression and attacks on civil society and critical voices in the country, including [police raids](#) on five prominent non-governmental organisations in Serbia.
- **8 March** - On the occasion of International Women's Day, La Strada International launched a [statement](#), calling for attention for forced marriage as a crime and as a form of human trafficking.
- **10 March** - LSI co-signed with 361 other CSO's a [statement opposing the European Commission's Omnibus proposal](#), which seeks to scale back key sustainability laws and reduce obligations for businesses.
- **12 March** - LSI co-signed a [statement](#) sharing solidarity with the people of Serbia, together with over 130 civil society organisations.
- **April** - policy brief with ASI - [Recommendations for the Designation of National Competent Authorities under the EU Forced Labour Product Ban Regulation](#)
- **12 May** - LSI endorsed an [open letter](#) to the Human Rights Council urging Member States to mandate a comprehensive study that translates existing theoretical frameworks into practical recommendations, providing States and institutions with tools, policies, and guidance to better integrate human rights into anti-corruption efforts.
- **13 May 2025** - the book [Human Trafficking and Sexual Exploitation Around the World](#) was launched. La Strada International (SH and Merel) wrote Chapter 13 - A critical look at the criminalization of the "Use of Services" of trafficked persons.
- **22 May** - LSI co-signed a [letter on fighting corruption](#), initiated by Transparency International and TI EU, who have been actively advocating at the EU Council and Parliament, and throughout the trilogue process for a strong EU Anti-corruption Directive and to uphold and strengthen the robust provisions adopted by the European Parliament in the proposed directive.
- **28 May** - LSI and over 300 national and international CSOs co-signed an [open letter](#) to the EU Commission to express concerns about the "Transparency of Public Life" bill, which enables the Hungarian government to target, defund and dissolve any organisation it designates as a threat to Hungarian sovereignty.
- **28 May** - LSI signed, together with over 80 CSOs, a [joint letter to Commissioner McGrath](#) raising urgent concerns about the Security Decree and wider shrinking civic space and rule of law in Italy.

Currently LSI is funded mainly by and involved in 9 projects. LSI currently has no core funding, as all applications for core funding failed, see below fundraising.

- **Forced Marriage project Open Gate** (research, campaign & event)/French government (2024 - 2025) – research and campaign launched with Open Gate and organised event on 10-12 September in Skopje with Open Gate. See campaign video [Документарен филм „Излез“/Documentary movie "Way out"](#)
- **Info Rights** (2024/2026/24 months) – for this project, that finished in February 2025, we have worked on a chatbot for posted workers <https://projetos.fiequimetal.pt/info-rights-chatbot/> and vlogs. See also <https://projetos.fiequimetal.pt/about/>
- **Mobile** (start 1 March 2025 – 2027, 24 months) – formally launched on 24/6 – a desk research has been submitted mid-October.
- **Trafficking En Route** (1 July 2025 – 30 June 2027) – LSI organised a workshop at the Platform; joined the kick off on 25-26 September 2025 in Amsterdam and worked on a stakeholders mapping and TOR Advisory board - *The 24-month EU (AMIF) funded project aims to address gaps in the identification, transnational assistance, and protection of TCN victims of trafficking for labour exploitation.*
