It is therefore understood that a decision on the mandate holders will be made depending of the RRI process of each of these mandates.

and

Ms. Nelsa Curbelo (Ecuador) and Ms. Mirjana Najcevska (The Former Yugoslav Republic of Macedonia) for the second mandate above

At the same time, a wish was expressed that Ms. Margaret Sekaggya (Uganda) be considered for this position.
